In 2015, Argentum formed the Senior Living Certification Commission (SLCC), a non-profit organization governed by industry leaders, dedicated to professional development initiatives for senior living executives and staff members.

The SLCC's Assisted Living Executive Director Certification program was developed by practicing subject matter experts in senior living, and is based on the unique knowledge and skills required by the executive director, as identified through an extensive job analysis. Utilizing standards for best practice in the certification field, this voluntary certification program takes existing state licensing requirements to the next level.

The Assisted Living Executive Director Certification examination provides a mechanism to measure judgment, and application of knowledge.

Individuals who pass the certification exam earn the Certified Director of Assisted Living (CDAL) credential.

ELIGIBILITY REQUIREMENTS

- Possess a bachelor's degree granted by a college or university that is accredited by an entity approved by the United States Department of Education, or the equivalent,
- Have at least three years work experience as an executive director of a licensed assisted living community OR five years work experience in a management capacity in one or more licensed assisted living communities, and
- Pass the certification examination for assisted living community executive directors.

OR

- Have at least five years work experience as an executive director of a licensed assisted living community OR seven years work experience in a management capacity in one or more licensed assisted living communities, and
- Pass the certification examination for assisted living community executive directors.



Our goal is to have all our residence directors obtain their SLCC Credential within the first few months of availability. For new directors joining us, we will strongly favor those candidates having previously obtained their SLCC Credential.
